3902 citizens were killed, an average of 132 people a day, 6 people an hour, 431 children, and 149 tortured to death.

The Syrian government and Alassad troops through the daily shelling, rids, massacres and torturing detainees to death, in addition to causalities of armed rebels through clashes killed 3902 citizen included:

149 tortured to death with an average of four citizens every day

431 children

449 women

The Syrian Network for Human Rights does not publish any statistics of whatever scale including daily statistics, without providing the human rights and the Arab and international media groups with lists of the names and not just the aggregate numbers.

We also add to the name a photograph and a video of the person that was mentioned on the same day. On the following days the team continues to seek to obtain pictures or videos of those who do not have any and once attained, they are directly added to the archive and attached with the name automatically to maintain accuracy and credibility.

The preparation of women and children to the total number of martyrs reached 5.1 which is definite and strict evidence that the Syrian government forces targeting the civilians, where in case of regular warfare the international accepted figure is 2%, the Syrian government exceeded twice this percentage and in another months exceeded up to three times this percentage Total numbers of victims dispersed all across provinces of Syria as follows: Damascus suburbs: 990, Aleppo: 696, Homs: 482, Damascus: 412, Daraa: 348 Idlib: 295, Hama: 169, Deir Alzour: 194, Alraqaa: 122, Qunaitra: 63,

Hasaka: 36, Lattakia: 30, Tartous: 6.

It is their moral and legal duty to meet their obligations and accelerate the process of referring all those responsible for crimes against humanity in Syria to the ICC.
