A- Introduction:

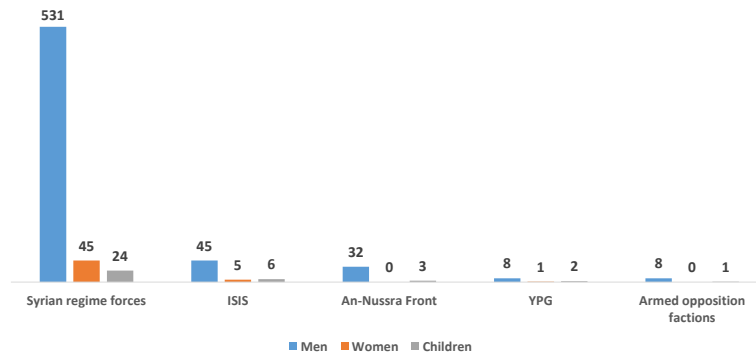
Details about detainees can be found through the search engine on SNHR website, you may also add the name and details of any detainee as the team concerned will check the data and upload it if proved accurate.

The following Tables show the arrests made in April that we were able to document. It should be noted that this is the minimum number of arrest cases on account of the fact that SNHR is banned and its activists are pursued by various parties.

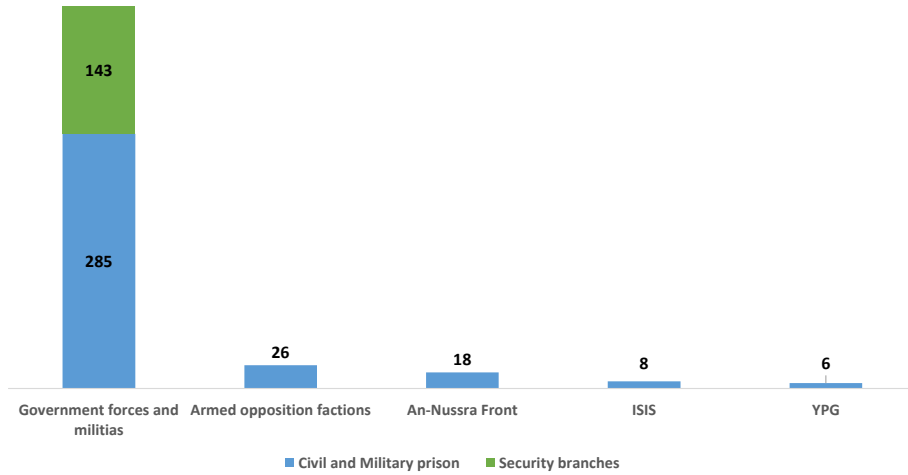
The Syrian Government denies it has executed the arrests and abductions when questioned by the families of the detainees as SNHR obtains most of the information from former detainees.

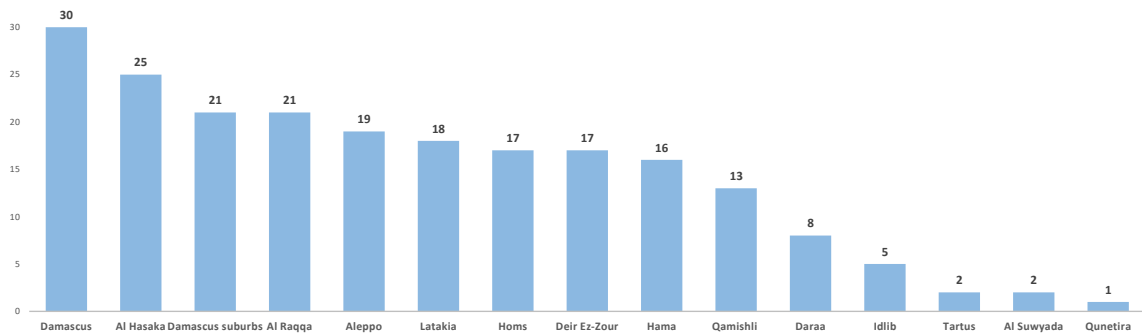




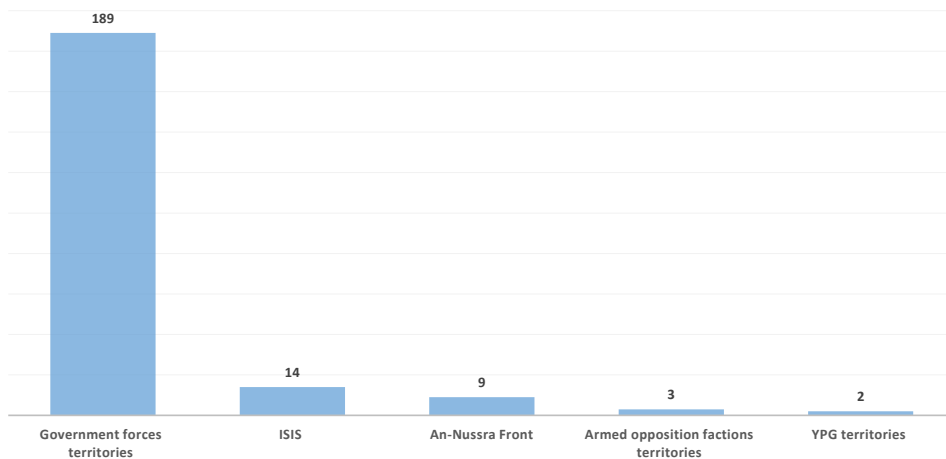
Releases in April 2015



Locations of raids and inspection points that resulted in detention:

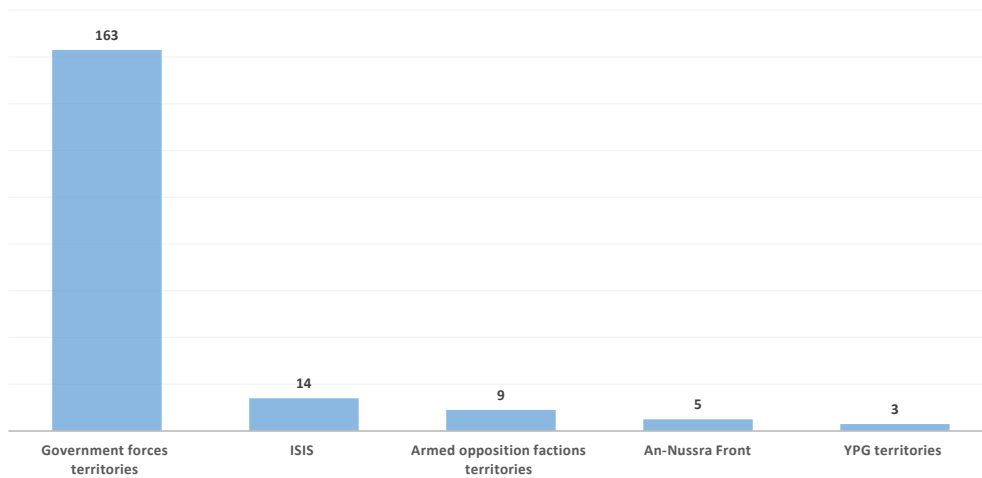


Parties responsible for arrests

C- Most Notable Arbitrary Arrest Cases in April:

a. Government forces:

- Munaem Haylaneh, age 52, a lawyer from Henayeh in Damascus suburbs, on April 1st 2015, he was arrested by government forces in Al Jedaydeh at the Syrian-Lebanese border and taken to Military Security Branch 235. He was released on April 9th 2015.

- Saleh Al Nabwani, age 44, a human rights activist and an opposition member, from As Suwayda, on April 7th 2015, he was arrested by government forces at the Syrian-Lebanese border on his way back from Beirut, his fate doesn't know anything of his fate.



- Jamal Jamad, age 51, from Al Yarmouk Camp, a Syrian-Palestinian human relief activist and head of Palestine Red Crescent in Al Yarmouk Camp, on April 5th 2015, he was arrested by government forces at a checkpoint located at the entrance of Al Yarmouk Camp. He is currently detained at Palestine Security Branch.





- (unnamed for security reasons), a 29 years old female from Al Zabadani in Damascus suburbs, on April 23rd 2015, she was arrested by government forces at Bloudan Arch checkpoint, her fate remains unknown for SNHR as we are yet unable to determine her place of detention.

b. Extremists groups:

- [Salman Mawas](#), age 30, from Bsakla in Idlib suburbs, fighter with the armed opposition, on April 4th 2015, he was arrested by An-Nusra Front fighters at a checkpoint in Attamah village, and we are yet unable to determine his place of detention.

- Hasan Shartah, age 39, from Kafr Nabl in Idlib, a judge at the Sharia Court in Hass village in Idlib suburbs, on Friday April 3rd 2015, fighters from An-Nusra Front arrested him from his residence in Kafr Nabl.



c. YPG

- [Dalshad Abdullah Mahmoud Jahour](#), 17 years old from Al Malikiyah in Qamishli countryside, on April 9th 2015, he was arrested by YPG fighters from his workplace in Al Malikiyah, SNHR is yet unable to determine his place of detention.

- Dilber Ahmad Haji, 16 years old girl from Ein Al Arab in Aleppo. On April 4, 2015 YPG gunmen arrested her from her residence in Ein Al Arab as part of the ongoing campaign of arresting and abducting children in order to recruit them.



D- Recommendations:

1- Security Council must see to the implementation of the resolutions:

2042 adopted on April 14, 2012

2043 adopted on April 21, 2012

2139 adopted on February 22, 2014 that states an end to the arbitrary arrests.

2- United Nations and the International Community must shoulder their responsibilities regarding hundreds of thousands of detained and missing individuals in Syria.
